- There will be 19 accessible units available (11 Mobility units and 8 Sensory units)
- Household sizes will range from one to five people with annual household incomes up to \$74,900. Note: Income and Rent limits are adjusted each year by the State to account for economic factors such as inflation (for current income limits, refer to the table)
- The property will accept applications from October 1, 2024 to October 30, 2024 with a computerized lottery on November 15, 2024.
