Supportive Housing for Homeless & Chronically Homeless Households. Supportive Housing units are restricted to households earning 15% to 50% of the Area Median Income (AMI) for the County of Los Angeles, as indicated in the chart on page 2. **There is no minimum income requirement for units with rental subsidy voucher.**

ACCESIBLE UNITS



Mobility impaired households will have priority for (3) units designed for the mobility impaired. A person with a disability may request a reasonable accommodation (a reasonable change in policies), a reasonable structural modification, an accessible unit or the provision of auxiliary aids and services, in order to have equal access to a housing program. If you or anyone in your household has a disability, and because of that disability requires a specific accommodation, modification or auxiliary aids or services to fully use our housing services, please contact our staff for a reasonable accommodation form.

RENT/ INCOME RESTRICTION

Voltaire Villas is an affordable tax-credit housing apartment community located in Los Angeles, California. To qualify applicants must have a gross monthly income that is at 1.5 times the monthly rent. Voucher holders do not need to meet the minimum gross monthly income requirement. **Subject to change.**

*There is no minimum income requirement for Project Based Voucher units and individuals will pay approximately 30% of their adjusted monthly income in rent as determined by the Housing Authority. Income is restricted in accordance with the Low-Income Housing Tax Credit (LIHTC) program and other regulatory agreements. Income limits subject to change.

INCOME LIMITS

Applicants must have incomes at 15% AMI to 50% of the Area Medium Income for Los Angeles County for their household size. See the chart below. **Subject to change.**
