Adda & Paul Safran Senior Housing is located just steps from the sands of the Pacific Ocean in Venice. Serving seniors 62 and older earning low incomes, this community has 62 one-bedroom apartments (four are mobility and two are hearing/vision apartments). The waitlist opens and accepts applications on July 21, 2025, and closes August 4, 2025.

The maximum income limits are as follows:

1 Person: \$53,000; 2 Persons: \$60,600; 3 Persons: \$68,150

Rent is 30% of the adjusted income. Once applications are received and the waiting list closed on August 4, 2025, applicants will be placed on the waiting list based on a lottery draw. All received applications up until the date the waiting list is closed will be entered into a lottery software and assigned a number which will determine placement on the waiting list.

If you have a disability and as a result of said disability need a reasonable accommodation, we will ensure said accommodation request is promptly addressed.
